8. The draft order which is uploaded must clearly reflect the surname of the Judge, date being 15 July 2022, the name of the counsel, the attorney and their respective e-mail addresses. If the phrase "Further or/and alternative relief" appears in your draft order it must be deleted.

9. All documents should be uploaded by 13:00 on Wednesday 13 July 2022. If the documents are not in order, the matter will be removed from the roll. No late documents may be uploaded. If for some reason you are unable to upload the draft order, you may e-mail it to JHefer@judiciary.org.za.
