**TO: ALL LEGAL PRACTITIONERS:**

1. Kindly take note that **ACTING JUDGE MATSETELA** will be presiding over the Trials/Special Interlocutory and Default Applications in the week 07 April-10 April 2026.
2. All applications will be heard in **OPEN COURT**, commencing at **09:30** each day, SIC matters will be heard first followed by default matters on completion of the SIC roll. A SIC and Default Trial roll is attached herein, please further take note that it is your responsibility to peruse the day roll to ascertain the court room matters will be heard.
3. All papers should already be uploaded in accordance with the practice directive. Failure to do so will result in the striking of the matter from the roll.
4. Please ensure that the draft order is uploaded to caselines in word and PDF format by 16:00 one Calendar Day before the hearing.

5. Legal practitioners must ensure the draft order contains the correct date of hearing, correct number of the matter on the roll, correct case number, correct names of the parties, correct Acting Judge's surname and if there's any amendment made by manual script, such amendment must be initialled.
6. The Draft order for **SIC Applications** must include that the Respondent is ordered to comply with the Court Order within **15 (FIFTEEN) DAYS** of service of the order.
7. Further, include that the Respondent is ordered to pay costs in **PARTY AND PARTY SCALE A.**
8. The draft order which is uploaded must further reflect the name of the counsel, the attorney and their respective email addresses and the disclaimer. If the phrase "Further or/and alternative relief" appears in your draft order it must be deleted.
9. Include the following Disclaimer: *This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or his/her secretary. The date of this Order is deemed to be the set down date.*
