If a **draft order** is to be made an order of court, **one hard copy** must be brought to be handed up in court. **Draft Orders and settlement agreements**, if applicable, must correctly indicate the Judge's name (i.e. Baqwa J), date on which the matter was heard, in which court and at the end of the draft order the party must indicate the name and contact details of their counsel and their instructing attorney.
