**DIRECTIVE**  
**SPECIAL INTERLOCUTORY COURT**

**BEFORE THE HONOURABLE ACTING JUSTICE NGENO**  
**2026 : Term 2 : Week 3 ; 29 April 2026**

1. **Kindly be advised that the proceedings for Wednesday, 29 April 2026 will be held virtually.** The link to the proceeding will be circulated on the WhatsApp groups of the Pretoria Attorneys Association ("PAA"). The link also appears below. Court will commence at 10H00 and representative are to join at least at 09H45 in order to resolve any technical issues to avoid delaying the proceedings.
2. The parties should ensure compliance with the relevant practice directives.
  1. A Practice Note comprehensively indicating the issues to be decided upon in the matter must be uploaded on Caseline as well as to be emailed to the email address below by no later than 12h00 on Friday 23 April 2026. Failure to file a comprehensive Practice Note may result in the matter being removed from the roll due to papers not being in order.
  2. **The Practice Note must contain detailed contacts particulars especially of the Legal Practitioner appearing (Cell numbers and email addresses) In the event that the person instructed to appear changes an additional updated Practice Note must again be filed before proceedings start.**
  3. A proposed Draft Order, in word format, must be uploaded under a newly created section on Caseline with the heading 'Draft Order 29 April 2026' as per the time frames set out in paragraph 3 above. Any and all attachments to the Draft Order must be filed thereunder



as well. The Draft Order must contain the Judge's Name, correct date, correct case number and parties details as per the papers.

4. **In the event that amendment needs to be effected to Draft Orders, such must be uploaded and Counsel needs appear to confirm the correctness before the order is granted.**
5. No further documents are to be uploaded after the cut-off time indicated in the practice manual as read with the practice directive of this court unless with the express permission of the Honourable Judge. Non-Compliance may result in the matter being removed from the roll due to papers not being in order.
6. In matters that will not proceed, Legal Practitioner are urged to inform the Judge's Chambers as soon as possible.
7. In the event that a matter does not appear on the roll, the instructing Attorney is to prepare an affidavit on all the steps taken, as per the directive, to have had the matter enrolled. The matter will then be considered for enrolment. The filing of the affidavit must comply with the timeframes set of in paragraph 3 above. The writer hereof must also be notified per email.
