### **DIRECTIVE: URGENT COURT BEFORE DU PLESSIS J**

**28 APRIL 2026**

All practitioners appearing in the urgent court are required to acquaint themselves with the terms of this directive, read together with the applicable Practice Manual and any directives issued by the Judge President.

#### **1. UNOPPOSED MATTERS**

All unopposed matters enrolled on the urgent roll will be heard in open court on Tuesday, 28 April 2026, at 10h00, unless otherwise indicated.

Practitioners must ensure that all papers are properly issued, served and fully uploaded on CaseLines.

A draft order in editable format must be filed electronically, emailed to TLNkuna@judiciary.org.za, and be available in hard copy at the hearing.

Where a matter becomes opposed, this must be communicated without delay to TLNkuna@judiciary.org.za. The matter will then be managed as an opposed urgent application.

#### **2. OPPOSED MATTERS**

Opposed urgent matters will be allocated specific hearing times during the week, as indicated below. All matters to be heard in open court unless otherwise requested.

All opposed matters must include a concise practice note and draft order filed on CaseLines and emailed to **TLNkuna@judiciary.org.za**. The practice note must at minimum set out:

- the nature of the relief sought;
- a brief summary of the material facts and the principal legal issues;
- the basis upon which urgency is alleged;
- an indication of which parts of the record the court should read;
- the estimated duration of argument; and
- the names and full contact details of all legal representatives.

#### **3. CASELINES / COURT ONLINE TECHNICAL PROBLEMS**
