CIVIL TRIAL DEFAULT JUDGMENT

Directives for the period 09 June 2026 to 12 June 2026

1. Introductions will be done in Open Court when the matter is called.2
2. All settlements, postponements and/or removals must immediately be brought to the attention of the Registrar and the Judge, by way of a “widely shared note” on Caselines, and by way of an e-mail transmitted to RMahori@judiciary.org.za.
3. **N:B KINDLY TAKE NOTE OF THE FOLLOWING:**
 - **Matters 1 – 27 will be heard on Tuesday**
 - **Matters 28 – 47 will be heard on Wednesday**
 - **Matters 48 – 67 will be heard on Thursday**
 - **Settlements, removals and postponements may be mentioned prior to their allocations date.**
4. Settlements, removals and postponements will be called first and thereafter the roll will be called by seniority.
5. Heads of argument are to be uploaded to Caselines, by no later than Friday 5 June 2026 at 16:00. Failure to comply may cause the matter to be removed from the roll.
6. Draft orders, which comply with the relevant requirements of this division regarding form and contents, to be uploaded to Caselines. One hard copy must be brought to Court. The number on the roll and the usual disclaimer

must be included.

7. A separate section 0, or any other number ensuring it is the top section, must be created at the top of the Caselines and name “heads of argument and relevant documents” which shall include the following documents (where relevant):

- 7.2. Practice note.

- 7.3. Strike-out order.

- 7.4. Heads of argument.

- 7.5. Latest actuarial report.

- 7.6. Section 19(f) affidavit and AR form.

- 7.7. Merits concession/settlement (offer and acceptance).

- 7.8. Confirmation of seriousness of injuries/HPCSA outcome.

- 7.9. Order appointing *curator ad litem*.

- 7.10. Contingency fee agreement.

8. Where a standdown of the matter will be requested to later in the week, an e-mail must preferably be sent to RMahori@judiciary.org.za before Monday 8 June 2026.

9. There will be no standdowns to Friday 12 June 2026.
