DIRECTIVE BY HONOURABLE GOVENDER AJ

1. The Judge will hear the matters in physical court.
2. The roll will commence from 10am. Removals will be dealt with from 10am to 10-15am. Thereafter the roll will be called in order of seniority.
3. Practitioners may introduce themselves in Court.
4. An appearance will be required in all matters save for those removed by Notice.
5. Draft Orders must be duly completed and compliant (i.e it must contain the details of Counsel, reflect the date of the hearing, the number as indicated on the roll, the Judge's particulars). DRAFT ORDERS MUST BE UPLOADED TO CASELINES AND COUNSEL MUST BRING TWO COPIES TO COURT. THIS ORDER (THE PHYSICAL COPIES) MUST SIGNATURE READY, (i.e. REMOVE THE WORD DRAFT FROM THE TRAMLINES).

6. If Counsel is not present and has not been excused the matter will be moved to the end of the roll and called again. If Counsel is still not present at the second calling, the matter will be removed from the roll. “
