DIRECTIVES:

1. All unopposed divorces and unopposed applications will be heard on **Monday, 8 June 2026** at **10h00** during a physical court hearing.
2. All opposed applications and urgent applications will be heard from **Tuesday, 9 June 2026** onwards and will be heard during a physical court hearing. **Matter no.41 will be heard on Tuesday, 9 June 2026 at 10h00.**
3. The Judge invites all practitioners to indicate, should they so wish, by which pronouns they wish to be addressed.
4. Introductions will be done in court.

5. Matters that become settled, removed or postponed by agreement must be communicated by email to the Judge's secretary Ms. Leletu Siqola LSiqola@judiciary.org.za without delay.
6. If a draft order is to be made an order of court, one hard copy must be brought to be handed up in court. Draft orders and settlement agreements, where applicable, must correctly indicate the Judge's correct particulars, **F BEZUIDENHOUT**, case number and date of hearing, the court and the correct names and contact details of both Counsel and their instructing attorney.
7. Court orders will be stamped, signed and uploaded within 7 court days.
8. The court will not deal with matters that were not placed timeously. If your matter was properly enrolled but does not appear on this roll, please contact or approach the enrollment office.
9. In respect of the unopposed divorces, the following directive will apply:-
 - 9.1 In matters where there are no minor children and where the parties concluded a written settlement agreement, evidence will be received by the Court by affidavit, unless the parties receive a note from the judge to the contrary on caselines.
 - 9.2 In matters where there are no minor children and where there are no written settlement agreements, evidence will be received by the Court by affidavit, unless the parties receive a note from the judge to the contrary on caselines.
 - 9.3 In ALL matters where there are minor children, oral evidence will be received by the Court.
 - 9.4 In ALL matters where parties are unrepresented, oral evidence will be received by the Court.

10. The judge may communicate with the parties' representatives via widely shared notes posted on the electronic file. Legal representatives are to look out for these communications and are requested to respond to such communications.

11. Parties with matters on court online are to ensure that the Judge has access to the caselines bundle by no later than **Friday, 5 June 2026 at 16h00**, or matters may run the risk of being removed.
