1. Matters will be heard in open court commencing at 10:00 (court to be allocated).
2. Counsel appearing can introduce themselves in open court.
3. Except for the two opposed matters where specific dates and times have been allocated for hearing and indicated on the roll, all matters will be called on Monday, 8 June 2026.
4. Legal Practitioners are to consider any widely shared notes in relation to their matters.
5. Removals, postponements, and settlements will be called first, and matters will thereafter be called in preference of seniority of counsel appearing in the matter.
6. Legal practitioners must ensure that draft orders are uploaded onto Caselines in Word format.

7. Parties are to bring two hard/printed copies of the draft order to be handed up in court.
8. Complete details of the parties' representatives (including counsel), judge's name (MENTZ AJ), date of hearing, and Court number should be included in the draft order.
9. The following disclaimer/qualification should be included in every draft order:

11. In all **opposed** matters set down for hearing during the week of 8 – 12 June 2026, heads or argument (original or supplementary) are to be uploaded no later than **12h00 on Thursday, 4 June 2026**. Failure to comply may cause the matter to be removed from the roll.
