**Directives:**

1. Introductions will be done in open court when a matter is called.
2. All settlements, postponements and/or removals must immediately be brought to the attention of the Registrar and the Judge, by way of a "widely shared note" on CaseLines, and by way of an email transmitted to [TKabai@judiciary.org.za](mailto:TKabai@judiciary.org.za).
3. Settlements, removals and postponements will be called first.
4. Thereafter, matters will be heard in order of seniority of the practitioner arguing the matter.
5. Heads of argument, a draft order in WORD and all other court documents, to be uploaded to CaseLines, no later than Friday, 12 June 2026 @16h00. Failure to comply may cause the matter to be removed from the roll.
6. Draft orders, which comply with the relevant requirements of this division regarding form and contents, to be uploaded to CaseLines in WORD. One (1) HARD COPY must be brought to court. The number on the roll and the usual disclaimer must be included.
7. A separate section 0, or any other number ensuring it is the top section, must be created and situated AT THE TOP of the CaseLines index and titled "HEADS OF ARGUMENT AND RELEVANT DOCUMENTS" which shall include the following documents (where relevant):
  - 7.1 Notice of set down.
  - 7.2 Practice note.
  - 7.3 Strike out order and or served interlocutory court order.
  - 7.4 Suggested draft order in Word.
  - 7.5 Heads of argument.
  - 7.6 Latest actuarial report (report only without notices).
  - 7.7 Section 19 (f) affidavit(s) and AR Form.
  - 7.8 Merits concession / settlement (offer and acceptance).
  - 7.9 Confirmation of seriousness of injuries / HPCSA outcome.
8. Matters are allocated to be heard on the following dates:
  - 8.1 Matters 1 to 20 will be heard on Wednesday
  - 8.2 Matters 21 to 40 will be heard on Thursday
  - 8.3 Matters 41 to 54 will be heard on Friday
  - 8.4 Should any matter become settled or is to be removed, legal practitioners are invited to mention these matters on a day sooner than the allocations in paragraphs 8.2 to 8.3 above.
