6. Notice of removal should be uploaded on caselines for the matters that are removed.

- 7.** Where opposition by the respondent in person is expected (i.e., notice of intention to oppose has been filed or the applicant's attorneys were contacted by the respondent), the applicant is required to contact the respondent and inform the respondent that written submissions under oath should be sent to the abovementioned email address.

- 8.** As soon as an application becomes removed, settled or the parties agree to postpone, electronic notification should be sent to Ms. Rinae Mavhungu (Judge's Secretary) RinMavhungu@judiciary.org.za

- 9.** Parties appearing in person can come to the High Court Building and notify Ms Mavhungu of their presence in Chamber No 119 at The Palace.
