6. Legal practitioners must hand in only one copy of the draft order in court. The draft order must contain date of hearing, court room ,correct matter number and the Judge's surname (**Madam Justice Janse Van Nieuwenhuizen**).
7. Legal practitioners must before handing in the draft order in court, ensure that the draft order contains the correct case number, correct name of the parties and if there's any amendment made by manual script, such amendment must be initialled or signed by the legal practitioner.
8. The court will not deal with matters that were not placed timeously, if your matter was properly enrolled but does not appear on this roll, please contact or approach the enrollment office.
9. Please note that court orders will be stamped, signed and uploaded within 7 court days.
