6. If a draft order is to be made an order of court, one hard copy must be brought to be handed up in court. Draft orders and settlement agreements, where applicable, must correctly indicate the Judge's correct particulars, **F BEZUIDENHOUT**, case number and date of hearing, the court and the correct names and contact details of both Counsel and their instructing attorney.
7. The court will not deal with matters that were not placed timeously. If your matter was properly enrolled but does not appear on this roll, please contact or approach the enrollment office.
