6. If a draft order is to be made an order of court, one hard copy must be brought to be handed up in court. Draft orders and settlement agreements, where applicable, must correctly indicate the Judge's correct particulars, **K.PILLAY AJ**, case number and date of hearing, the court and the correct names and contact details of both Counsel and their instructing attorney and include the below disclaimer:
