6. Introductions will take place at office 2 (Palace of the Justice) at 09h45.

7. Legal practitioners must hand in only one copy of the draft order in court. The draft order must contain date of hearing, court room ,correct matter number and the Judge's surname (**Madam Justice Janse Van Nieuwenhuizen**).
8. Legal practitioners must before handing in the draft order in court, ensure that the draft order contains the correct case number, correct name of the parties and if there's any amendment made by manual script, such amendment must be initialled or signed by the legal practitioner.
